SOP Purpose: To provide procedures for reporting suspected Child Abuse to Child Protective Services (CPS).

Applicability: All YMCA Fox Cities staff

Policy:

- All YMCA of the Fox Cities employees are mandated reporters. Any staff member who suspects abuse must report it.
- Begin with a YMCA of the Fox Cities incident report and notify your supervisor of the situation.
- Reports to Child Protective Services should be made as soon as possible and must be made within 24 hours of suspecting abuse.
- In preparation to make the call, fill out the CPS form below.
- If multiple staff suspect abuse, each staff member must report individually.
- This information is confidential. Do not share with anyone other than co-workers directly involved and immediate supervisors.
- Have your supervisor or other member of Management Team present when you make a report. However, the responsibility to report lies with the staff member who suspects abuse.
- After completing the call turn the incident report and CPS form to your Branch Executive.

Procedure:

If you suspect abuse and the child is old enough to speak, ask the child non-leading questions to gain more information about your concerns:

If you need to report:

- Fill out Child Protective Services (CPS) Mandated Reporting form as completely as possible.
 Most demographic information can be found in Daxko. If there is information you are not
 able to find leave it blank. In describing the incident, be objective, use facts and direct
 quotes.
- 2. If you feel child is in immediate danger call 911.
- 3. If child is not in immediate danger, call the appropriate county. (Numbers are listed on the Child Protective Services (CPS) Mandated Reporting form. If you do not know the county you can Google it by address. If you call the incorrect county they will transfer you to the correct one.
 - a. If CPS answers your call:
 - i. Tell them your name, that you are calling from the YMCA of the Fox Cities and are a mandated reporter.
 - ii. Record the name of CPS staff person as well as the date time on the Child Protective Services (CPS) Mandated Reporting form.
 - iii. Answer all questions asked of you regarding the incident.
 - iv. At the conclusion of the conversation ask CPS any question you have. For example, should contact the parent to let them know you made the call?
 - v. Verify all the information you are able to fill out on the Child Protective Services Mandate Reporting form is filled out completely. Turn the form into your Executive Director.
 - b. If you are forced to leave a message with CPS, in the message state your name, that you are calling form the YMCA of the Fox Cities, you are a mandated report, a phone number that you can be reached at and a good time for CPS to call you back. Keep the Child Protective Services Mandated Reporting form with you until you

have received a return call and made the report. Once you have made the report (following the directions in point a), turn the form into your Executive Director.

- 4. After report is made CPS will send a letter to the appropriate YMCA explaining the follow up that was taken. This letter is given to the staff who reported. The Y does not need to retain a copy.
- 5. All mandated reports are kept confidential from both the Y and CPS. If you were to be asked if you made a report, do not confirm or deny, let the person know that all YMCA staff are mandated reporters and act on the best interest of every child.
