This is a summary of the annual report of the YMCA OF THE FOX CITIES EMPLOYEE WELFARE BENEFIT PLAN, EIN 39-0806191, Plan No. 504, for period 01/01/2020 through 12/31/2020. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

YOUNG MEN'S CHRISTIAN ASSOCIATION OF THE FOX CITIES, INC. has committed itself to pay certain self-funded Medical and Dental claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with SUPERIOR VISION INSURANCE PLAN OF WISCONSIN, INC., UNITED HEALTHCARE INSURANCE COMPANY, and THE LINCOLN NATIONAL LIFE INSURANCE COMPANY to pay Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, Managed Organ, Tissue Transplant, and Tissue transplant claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2020 were \$77,965.
